(4) The assessment year to which said expenditures, labor and improvements applies is that commencing September 1, 1974 and ending September 1, 1975; AND,

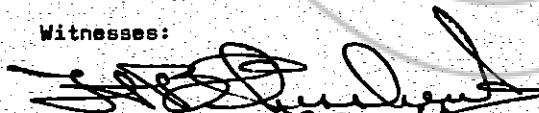
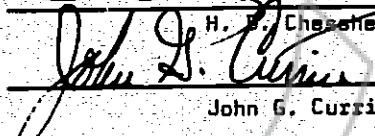

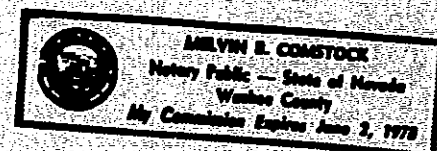
