

PARTIAL RECONVEYANCE

Lots 5 and 6 in Block 29 of the town of Beowawe, according to the map thereof, filed in the Office of the County Recorder of Eureka County, State of Nevada, on June 15, 1908, under File No. 2166.

RESERVING THEREFROM a portion of mineral rights to Southern Pacific Land Company and further reserving unto Dextra Baldwin Mc Gonagle a 1/3 interest in the mineral rights until June 14, 1976 and further reserving unto Baldwin M. Baldwin a portion of mineral rights until June 14, 1976.

The remaining property described in said Deed of Trust shall continue to be held by said Trustee under the terms thereof. As provided in said Deed of Trust, this Partial Reconveyance is made without affecting the personal liability of any person for payment of the indebtedness secured by said Deed of Trust.


