That such work was performed during the period between September 1, 1974 and September 1, 1975.

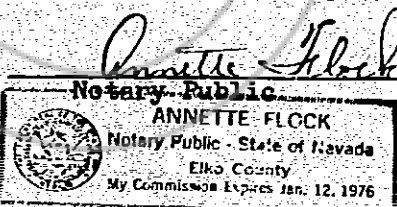
