convey, mortgage, and hypothecate lands, tenements, and hereditaments,
upon such terms and conditions, and under such covenants as He
shall think fit. Also, to bargain and agree for, buy sell, mortgage,
hypothecate, and in any and every way and manner deal in and with goods,
wares, and merchandise, choses in action, and other property in
possession or in action, and to make, do, and transact all and every
kind of business of what nature kind soever, and also for us and in
our name s and as our act and deed to sign, seal, execute,
