The above-entitled matter having come on for trial on Friday,
August 29, 1975 at 10:00 a.m. before the Honorable G. Hal Taylor, the
Plaintiffs appearing and being represented by their attorney D. Clayton
Fairbourn and the Defendants appearing and being represented by their
attorney Robert K. Mouritsen. The parties having stipulated that Goldie
Poulsen could be joined as a Plaintiff in this action and Beverly Bleazard
could be joined as a Defendant and Counterclaimant. The Court having heard
the evidence presented by both Plaintiff and Defendant being fully advised
in the premises hereby enters judgment as follows: Plaintiffs Earl A.
Poulsen and Goldie Poulsen are awarded judgment against Defendant William
W. Bleazard and Beverly Bleazard in the sum of \$5,000.00 plus interest at
6% per annum from the 14th day of September, 1972, to the date of entry of
judgment and interest at the rate of 8% per annum thereafter, plus costs in
the amount of \$123.90.

It is further ordered that if within ten (10) days of the entry of Judgment the Defendants fail to pay the amount of the said Judgment plus interest and costs that a 12-1/2% interest in the following described property located in Eureka County, Nevada, described as follows:

by the parties known as the West Capitol Hill properties be sold. That the
parties reach a mutual accord as to the division of the proceeds from such
sale. That should the parties fail to reach an accord that further hearing be
held to determine an equitable division of the proceeds of the sale.
