

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Ant #36 Lode Mining Claim in Section 14, Township 18 north, Range 52 east, in the unorganized Mining District, in Eureka County, in the State of Nevada, on the 3rd day of October, 1975.

The claim is 1500 feet long and 600 feet wide, and 1450 feet is claimed in a north direction and 50 feet in a south direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the south to the north.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by inscription on aluminum tab attached to post.

- Corner No. 1 is a 4" x 4" wooden post
- Corner No. 2 is a 4" x 4" wooden post

- Corner No. 6 is a 4" x 4" wooden post

The monumentation and marking of the corners was completed by the 3rd day of October, 1975.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
