

## CERTIFICATE OF LOCATION OF LODE MINING CLAIM

THIS IS TO CERTIFY that GEORGE NO. 6 Lode Mining Claim was located on the 12th day of September, 1975, by the undersigned, MINERAL SERVICES, INC., in an Unknown Mining District in Section 32, Township 31 North, Range 51 East, Eureka County, Nevada;

THAT on this date of recording this Certificate of Location, a Mining Claim Map of the GEORGE NO. 6 Lode Mining Claim and associated claims in the GEORGE LODE CLAIM GROUP is being recorded, and appropriate fees paid, at the office of the Eureka County Recorder;

THAT the undersigned claims fifteen hundred feet in length by six hundred feet in width, on this GEORGE NO. 6 lode, vein or deposit, and claims 1,495 linear feet along the course of the vein in a North 83° East direction from the Location Monument, and 5 linear feet along the course of the vein in a South 83° West direction from the Location Monument, and 300 feet in width on the Northerly side of the center of the vein, and 300 feet in width on the Southerly side of the center of the vein, the general course of said vein, as nearly as can be traced, being North 83° East, and the location being described and marked on the ground as follows, to wit:

Beginning at a point 5 feet South 83° West of the Location Monument; thence North 7° West 300 feet to the Northwest Corner, No. 1; thence North 83° East 750 feet to the North Side Center, No. 2; thence North 83° East 750 feet to the Northeast Corner, No. 3; thence South 7° East 600 feet to the Southeast Corner, No. 4; thence South 83° West 750 feet to the South Side Center, No. 5; thence South 83° West 750 feet to the Southwest Corner, No. 6; thence North 7° West 300 feet to the point of beginning.

Each of the above described corners and side centers is marked in accordance with the laws and regulations of the State of Nevada;

THAT the Location Monument of GEORGE NO. 6 Lode Claim lies approximately 2,191 feet North and 2,595 feet West of the Southeast Corner of Section 32, Township 31 North, Range 51 East.
