IT IS AGREED AND UNDERSTOOD that first party will lease and rent unto second party for the sum of ONE DOLLAR (\$1.00) per annum, commencing with the year 1975, all of the following described real property situate at and within the Town of Eureka, Nevada:

Brick building located on Lots 5 and 6 in Block 35, of the Town of Eureka, Nevada.

IT IS AGREED AND UNDERSTOOD between the parties hereto that said demised property shall be leased by first party unto the second party for a period of hearth (100 (25)) years, commencing with the execution date of this agreement and to be finished, terminated and concluded on the date of Accession 1975.

IT IS AGREED AND UNDERSTOOD between the parties hereto that in the event a beneficial program for the Senior Citizens
