TOGETHER with the buildings and improvements situate thereon.

TOGETHER with the tenements, hereditaments, and appurtenances thereunto belonging or appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, the said premises unto the Second Parties, as joint tenants with right of survivorship and not as tenants in common, and to the heirs, executors, administrators and assigns forever.
