

NOTICE

WAGE CLAIM LIEN

TO: WILLIAM LOWER and LOIS LOWER, his wife.

NOTICE IS HEREBY GIVEN pursuant to NRS Chapters 108 and 608:

1. That it is the intention of JULIAN GOICOECHEA, Claimant herein, to claim and hold a lien upon that certain tract of land hereafter described.

2. That after deducting all just credits and offsets a sum of ONE THOUSAND EIGHT HUNDRED FOUR and 80/100 DOLLARS (\$1,804.80) is due and owing the Claimant for labor and services rendered in connection with the cutting, baling, hauling and stacking of hay.

3. That the name of the reputed owner of the tract of land hereafter described and upon which this lien is to be held is WILLIAM LOWER and LOIS LOWER, his wife.

4. That the Claimant rendered services and performed work during the period August 1975 and from September 22, 1975 to October 29, 1975 and that the terms of his contract were as follows:

5. That THREE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$3,150.00) has been paid to the Claimant and the balance due and owing is \$1,804.80.

6. That demand for remainder due and owing to the Claimant has been made.

7. That the description of the land upon which said labor and services were rendered is a parcel of land consisting of 320 acres situated in Diamond Valley, Eureka County, State of Nevada, more particularly described as follows:

Together with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

8. That said labor and services were rendered at the request of WILLIAM LOWER and LOIS LOWER, his wife, owners of said property.

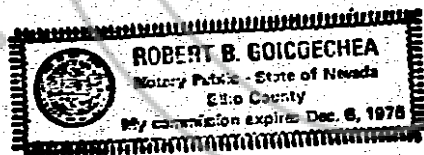
