W I T N E S S E T H:

That the party of the First Part, for and in consideration of the sum of TEN (\$10.00) Dollars, lawful money of the United States of America, to her in hand paid by the Party of the Second Part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and quitclaim unto the Party of the Second Part, and to his heirs and assigns forever, all her right, title and interest in fact or by operation of law in and to those certain lots, pieces or parcels of land situate, lying and being in the County of Eureka, State of Nevada, and particularly described as follows:

TO HAVE AND TO HOLD the said premises, together with all and singular the appurtenances, unto the said Party of the Second Part, and to his heirs and assigns forever.

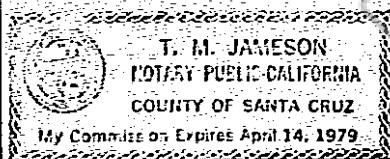
