

QUITCLAIM DEED

W I T N E S S E T H:

release and forever QUITCLAIM unto the said GRANTEE, and to her

TOGETHER WITH the tenements, hereditaments and  
appurtenances thereunto belonging or in anywise  
appertaining, the reversion and reversions,  
remainder and remainders, rents, issues and  
profits thereof.

EXCEPTING AND RESERVING all uranium, thorium,  
or any other material which is or may be deter-  
mined to be peculiarly essential to the pro-  
duction of fissionable materials, as reserved  
by the United States of America in Patent  
dated December 1, 1947, and recorded December 19,  
1947, in Book 23 of Deeds at page 226, Eureka  
County, Nevada.

TOGETHER WITH all and singular the tenements, heredita-  
ments and appurtenances thereunto belonging or appertaining, and  
the reversion and reversions, remainder and remainders, rents,  
issues and profits thereof.

TO HAVE AND TO HOLD THE premises herein granted unto  
the GRANTEE, and to her heirs and assigns, forever.
