release and forever QUITCLAIM unto the said GRANTEE, and to her

All of Block One Hundred Twenty-Five (125)
situate in the above named Townsite, County
and State, EXCEPT FOR that parcel or portion

of the State of Nevada, in and for the County
of Eureka, then and there being the Trustee
of the Eureka Townsite, as party of the first
part, to Sophia Hollan, the party of the
second part, said instrument of conveyance
bearing date August 5, 1948, and recorded in

Eureka at Eureka, Nevada, reference to which
said records is hereby made for greater
certainty and particulars.

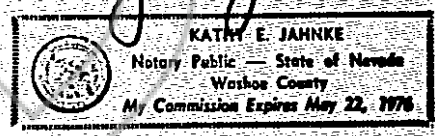
