AMENDED ARTICLES OF CO-PARTNERSHIP

WITNESSETH:

WHEREAS, the parties hereto did on the 2nd day of January, 1973, enter into Articles of Co-Partnership for the purpose of conducting a ranching and livestock operation in the State of Nevada under the name of DIAMOND LAND AND CATTLE; and

WHEREAS, it is the desire of the parties hereto to amend said Articles of Co-Partnership;

Third Party in the same percentages, and all profits and losses of the partnership shall be borne by the First Parties and the Third Party in the same percentages.

- The Second Parties waive any claims against the First Parties, the Third Party, and the partnership, except as specifically forth in Exhibit A, and the partnership, the First Parties and the Third Party waive any right of contribution, or any claim of any name or nature against the Second Parties arising out of their previous participation and interest in the partnership.
- The parties do by this agreement amend Paragraph 12, page 10 of the original Articles of Co-Partnership, to permit the voluntary withdrawal of Second Parties from the partnership.
- The First Parties and Third Party and the partnership 5. do hereby waive their right pursuant to Paragraph 18, page 13, to apply for a Nevada State Contractor's License and to do business under the fictitious name of DAMELE BROTHERS, and the Second Parties retain the right to conduct business under their existing Nevada State Contractor's license as DAMELE BROTHERS.


