GRANT, BARGAIN AND SALE DEED

Lots One (1) and Two (2), and East Thirty-four (34) Feet of Lot Three (3), in Block 122, in the Town of Eureka, County of Eureka, State of Nevada, as same are delineated on the Official Map or Plat of Eureka Townsite, on file in the office of Eureka County Recorder, Eureka, Nevada.

TOGETHER WITH all buildings and improvements situate thereon.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
