

MINERAL DEED  
UNPATENTED LODE MINING CLAIM

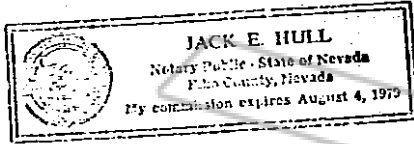
