THIS IS TO CERTIFY that the NEE 2 lode mining claim

CORTEX Mining District, EUREKA County, State of  
NEVADA, in Section 3, Township 26 N, Range 48 E.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending 20 feet from the location monument in a EASTWARD direction,  
and 1400 feet in a SOUTHWARD direction, together with 300 feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4 in. PIPE 4 feet high, inscribed "NW Corner  
of the NEE 2 Claim;" the southwest corner is marked by a 4 in. PIPE 4 feet  
high, inscribed "SW Corner of the NEE 2 Claim;" the southeast corner is marked by  
a 4 in. PIPE 4 feet high, inscribed "SE Corner of the NEE 2 Claim;" the  
northeast corner is marked by a 4 in. PIPE 4 feet high, inscribed "NE Corner of the  
NEE 2 Claim." There is also a 4 in. PIPE at the center of each side line.

The monumentation and marking of the corners was completed by the 14<sup>th</sup> day of MAY, 1976  
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.

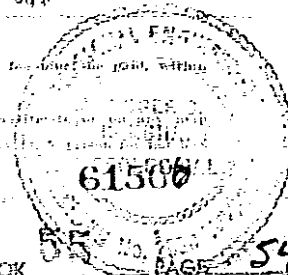
