CERTIFICATE OF LOCATION**LODE-QUARTZ**

THIS IS TO CERTIFY that the NNE 14 lode mining claim

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a WESTERLY direction,
and 1480 feet in a EASTERLY direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4 in. PIPE 4 feet high, inscribed "NW Corner
of the NNE 14 Claim;" the southwest corner is marked by a 4 in PIPE 4 feet
high, inscribed "SW Corner of the NNE 14 Claim;" the southeast corner is marked by
a 4 in. PIPE 4 feet high, inscribed "SE Corner of the NNE 14 Claim;" the
northeast corner is marked by a 4 in. PIPE 4 feet high, inscribed "NE Corner of the
NNE 14 Claim." There is also a 4 in. PIPE at the center of each side line.

The monumentation and marking of the corners was completed by the 14TH day of MAY, 19 76.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the EVANS County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.
