We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a WESTERLY direction,
and 1480 feet in a EASTERLY direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4 in. PIPE 4 feet high, inscribed "NW Corner
of the NEE 20 Claim;" the southwest corner is marked by a 4 in. PIPE 4 feet
high, inscribed "SW Corner of the NEE 20 Claim;" the southeast corner is marked by
a 4 in. PIPE 4 feet high, inscribed "SE Corner of the NEE 20 Claim;" the
northeast corner is marked by a 4 in. PIPE 4 feet high, inscribed "NE Corner of the
NEE 20 Claim." There is also a 4 in. PIPE at the center of each side line.

The monumentation and marking of the corners was completed by the 14TH day of MAY, 1976.
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.

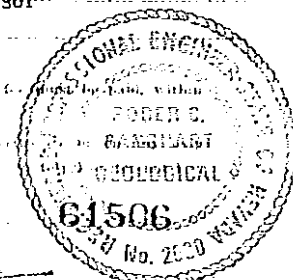
