N&E 21 Claim." There is also a 4 in PIPE at the center of each side line.

The monumentation and marking of the corners was completed by the 14<sup>TH</sup> day of MAY, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the EVAREKA County Recorder, and the \$15.00 lode claim
