We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or vein, extending **20** feet from the location monument in a **EASTERNLY** direction, and **1480** feet in a **WESTERNLY** direction, together with **300** feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4 in. Pipe 4** feet high, inscribed "NW Corner of the **N 25° E** Claim;" the southwest corner is marked by a **4 in. Pipe 4** feet high, inscribed "SW Corner of the **N 25° E** Claim;" the southeast corner is marked by a **4 in. Pipe 4** feet high, inscribed "SE Corner of the **N 25° E** Claim;" the northeast corner is marked by a **4 in. Pipe 4** feet high, inscribed "NE Corner of the **N 25° E** Claim." There is also a **4 in. Pipe** at the center of each side line.

The monumentation and marking of the corners was completed by the **4th** day of **MAY**, 19**76**.
