We for 1) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or

each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4 in. PIPE 4** feet high, inscribed "NW Corner

**NEE 27** Claim." There is also a **4 in. PIPE** at the center of each side line.

The monumentation and marking of the corners was completed by the **14<sup>TH</sup>** day of **MAY**, 19**76**.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the **EUREKA** County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
