We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or vein, extending **20** feet from the location monument in a **WESTERLY** direction, and **1410** feet in a **EASTERLY** direction, together with **300** feet on each side of the center of the ledge for the entire length of the claim.

There is also a **4 in. Pipe** at the center of each side line.

The monumentation and marking of the corners was completed by the **14th** day of **MAY**, 19**76**
(must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the **EVANS** County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

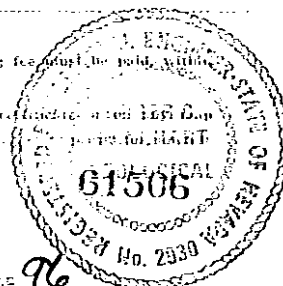
