We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a EASTWARD direction,
and 1450 feet in a WESTWARD direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner
of the NBE 52 Claim;" the southwest corner is marked by a 4 in. Pipe 4 feet
high, inscribed "SW Corner of the NBE 52 Claim;" the southeast corner is marked by
a 4 in. Pipe 4 feet high, inscribed "SE Corner of the NBE 52 Claim;" the
northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the
NBE 52 Claim." There is also a 4 in. Pipe on Post at the center of each side line.
