# CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the **NCE 69** lode mining claim

**CORTEX** Mining District, **EVANS** County, State of  
**NEVADA**, in Section **34**, Township **27 N**, Range **48 E**  
We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending **20** feet from the location monument in a **WESTERLY** direction,  
and **1500** feet in a **EASTERLY** direction, together with **300** feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4 x 4 Post 4** feet high, inscribed "NW Corner  
of the **NCE 69** Claim;" the southwest corner is marked by a **4 x 4 Post 4** feet  
high, inscribed "SW Corner of the **NCE 69** Claim;" the southeast corner is marked by  
a **4 x 4 Post 4** feet high, inscribed "SE Corner of the **NCE 69** Claim;" the  
northeast corner is marked by a **4 x 4 Post 4** feet high, inscribed "NE Corner of the  
**NCE 69** Claim." There is also a **4 x 4 Post 4** at the center of each side line.

The monumentation and marking of the corners was completed by the **15<sup>TH</sup>** day of **MAY**, 1976.  
(must be within 90 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the **EVANS** County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
