# CERTIFICATE OF LOCATION

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending 20 feet from the location monument in a WESTERLY direction,  
and 1480 feet in a EASTERLY direction, together with 306 feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner  
of the N.E. 73 Claim;" the southwest corner is marked by a 4x4 Post 4 feet  
high, inscribed "SW Corner of the N.E. 73 Claim;" the southeast corner is marked by  
a 4x4 Post 4 feet high, inscribed "SE Corner of the N.E. 73 Claim;" the  
northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the  
N.E. 73 Claim." There is also a 4x4 Post at the center of each side line.

The monumentation and marking of the corners was completed by the 17<sup>th</sup> day of MAY, 1976  
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
