 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4x4 Post 4** feet high, inscribed "NW Corner
 of the **N6E 77** Claim;" the southwest corner is marked by a **4x4 Post 4** feet
 high, inscribed "SW Corner of the **N6E 77** Claim;" the southeast corner is marked by
 a **4x4 Post 4** feet high, inscribed "SE Corner of the **N6E 77** Claim;" the
 northeast corner is marked by a **4x4 Post 4** feet high, inscribed "NE Corner of the
N6E 77 Claim." There is also a **4x4 Post** at the center of each side line.

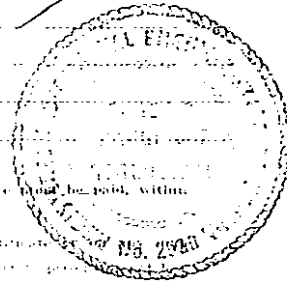
The monumentation and marking of the corners was completed by the **17th** day of **MAY**, 1976

 filing fee has been paid to the County Recorder.
