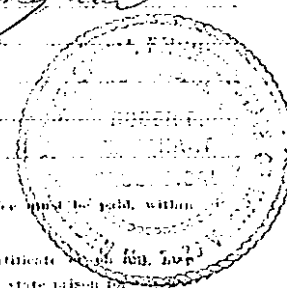

vein, extending 20 feet from the location monument in a WESTERLY direction,
and 1480 feet in a EASTERLY direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner
of the NCE 82 Claim;" the southwest corner is marked by a 4x4 Post 4 feet
high, inscribed "SW Corner of the NCE 82 Claim;" the southeast corner is marked by
a 4x4 Post 4 feet high, inscribed "SE Corner of the NCE 82 Claim;" the
northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the
NCE 82 Claim." There is also a 4x4 Post at the center of each side line.The monumentation and marking of the corners was completed by the 17th day of MAY, 1976
