We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or
vein, extending **20** feet from the location monument in a **NORTHEASTLY** direction,
and **1480** feet in a **EASTERNLY** direction, together with **300** feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4x4 Post 4** feet high, inscribed "NW Corner
of the **N.E.E. 93** Claim;" the southwest corner is marked by a **4x4 Post 4** feet
high, inscribed "SW Corner of the **N.E.E. 93** Claim;" the southeast corner is marked by
a **4x4 Post 4** feet high, inscribed "SE Corner of the **N.E.E. 93** Claim;" the
northeast corner is marked by a **4x4 Post 4** feet high, inscribed "NE Corner of the
N.E.E. 93 Claim." There is also a **4x4 Post** at the center of each side line.

The monumentation and marking of the corners was completed by the **18th** day of **MAY**, 1976
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the **EUREKA** County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.
