We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
vein, extending 20 feet from the location monument in a WESTERLY direction,
and 1480 feet in a EASTERLY direction, together with 300 feet on
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner
of the N.E.E. 93 Claim;" the southwest corner is marked by a 4x4 Post 4 feet
high, inscribed "SW Corner of the N.E.E. 93 Claim;" the southeast corner is marked by
a 4x4 Post 4 feet high, inscribed "SE Corner of the N.E.E. 93 Claim;" the
northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the
N.E.E. 93 Claim." There is also a 4x4 Post at the center of each side line.

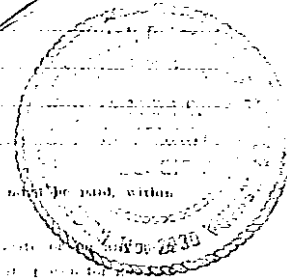
The monumentation and marking of the corners was completed by the 18th day of MAY, 1976
(must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
filing fee has been paid to the County Recorder.

not less than one year nor more than five years." NRS 517.045, Subsection 1.
