We (or I) claim ... 1500 ... linear feet along the course of the mineral-bearing ledge, lode or vein, extending 20 ... feet from the location monument in a 605.575147 ... direction, and 1480 ... feet in a 684.575147 ... direction, together with 300 ... feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4 x 4 Post 4 feet high, inscribed "NW Corner of the NEE 98 Claim;" the southwest corner is marked by a 4 x 4 Post 4 feet high, inscribed "SW Corner of the NEE 98 Claim;" the southeast corner is marked by a 4 x 4 Post 4 feet high, inscribed "SE Corner of the NEE 98 Claim;" the northeast corner is marked by a 4 x 4 Post 4 feet high, inscribed "NE Corner of the NEE 98 Claim." There is also a 4 x 4 Post at the center of each side line.

The monumentation and marking of the corners was completed by the 19th day of April, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the CLACK County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
