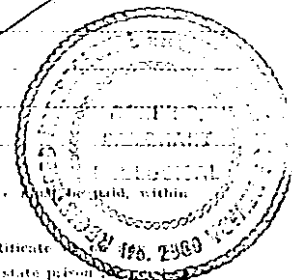

vein, extending 20 feet from the location monument in a WESTERNLY direction,  
and 1480 feet in a EASTERNLY direction, together with 300 feet on  
each side of the center of the ledge for the entire length of the claim.The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner

NEE 103 Claim." There is also a 4x4 Post at the center of each side line.The monumentation and marking of the corners was completed by the 19<sup>th</sup> day of April, 1976.
