We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 20 feet from the location monument in a WESTERLY direction, and 1400 feet in a EASTERLY direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner of the N.E.E. 106 Claim;" the southwest corner is marked by a 4x4 Post 4 feet high, inscribed "SW Corner of the N.E.E. 106 Claim;" the southeast corner is marked by a 4x4 Post 4 feet high, inscribed "SE Corner of the N.E.E. 106 Claim;" the northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the N.E.E. 106 Claim." There is also a 4x4 Post at the center of each side line.

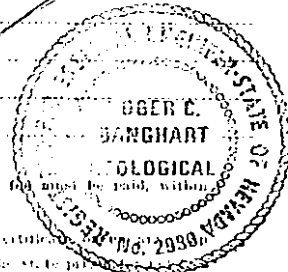
The monumentation and marking of the corners was completed by the 15th day of MAY, 1976

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
