# CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the NEE 108 lode mining claim

CORTEZ Mining District, EUREKA County, State of  
NEVADA, in Section 27, Township 27 N, Range 48 E

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
vein, extending 20 feet from the location monument in a WESTERLY direction,  
and 1470 feet in a EASTERLY direction, together with 300 feet on  
each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4x4 Post 4 feet high, inscribed "NW Corner  
of the NEE 108 Claim;" the southwest corner is marked by a 4x4 Post 4 feet  
high, inscribed "SW Corner of the NEE 108 Claim;" the southeast corner is marked by  
a 4x4 Post 4 feet high, inscribed "SE Corner of the NEE 108 Claim;" the  
northeast corner is marked by a 4x4 Post 4 feet high, inscribed "NE Corner of the  
NEE 108 Claim." There is also a 4x4 Post at the center of each side line.

The monumentation and marking of the corners was completed by the 19th day of MAY, 1976.  
(must be within 20 days of posting notice of location)


The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
