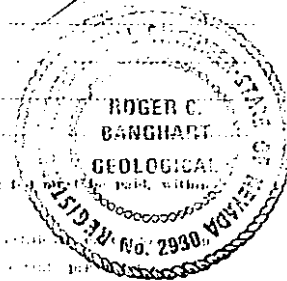

Pipe 4** feet high, inscribed "SE Corner of the **NEE III** Claim;" the northeast corner is marked by a **4 in. Pipe 4** feet high, inscribed "NE Corner of the **NEE III** Claim." There is also a **4 in. Pipe** at the center of each side line.

The monumentation and marking of the corners was completed by the **19<sup>TH</sup>** day of **MAY**, 19**76**.
