THIS AGREEMENT is dated April 13, 1976, between AMOS J. HARTE and DIXIE L. HARTE, called "Lessor", and STANDARD OIL COMPANY OF CALIFORNIA, a corporation, called "Lessee".

W I T N E S S E T H :

By Geothermal Resources Lease dated October 30, 1975, Lessor granted, let and leased unto Lessee the land therein described for the uses and purposes and upon the terms and conditions therein set forth, a Short Form of which lease was recorded in Book 53, Page 353, Official Records of Eureka County, Nevada.

The description of the land subject to said lease is incorrect and the parties desire to amend the lease to correct the description.

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) paid to Lessor by Lessee, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. That portion of Paragraph 1 of said lease describing the land included in and made subject to said lease which reads:

Section 27: S $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$;

is hereby amended to read as follows:

Township 30 North, Range 48 East, MDB&M

Section 27: W $\frac{1}{2}$ SW $\frac{1}{4}$ NE $\frac{1}{4}$.

2. As herein amended, said lease shall remain in full force and effect.

3. The provisions of this agreement shall be binding upon and shall inure to the benefit of the respective heirs, executors, administrators, successors and assigns of the parties hereto.
