Principal is payable in lawful money of the United State of America. If action be instituted on this Note, I promise to pay such sums as the Court may fix as reasonable attorney's fees.



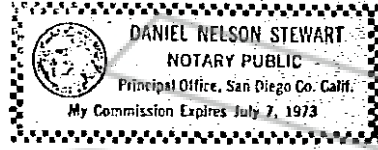
