The northwest corner is marked by a 4"x4" POST 4 feet high, inscribed "NW Corner

 high, inscribed "SW Corner of the NEE 123 Claim;" the southeast corner is marked by
 a 4"x4" POST 4 feet high, inscribed "SE Corner of the NEE 123 Claim;" the
 northeast corner is marked by a 4"x4" POST 4 feet high, inscribed "NE Corner of the
NEE 123 Claim." There is also a 4"x4" POST 4 at the center of each side line.

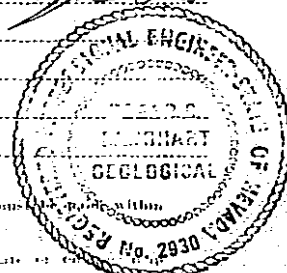
The monumentation and marking of the corners was completed by the 8th day of JUNE, 1976.
 (must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
 claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
 filing fee has been paid to the County Recorder.
