 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4" PIPE 4** feet high, inscribed "NW Corner
 of the **NEE 126** Claim;" the southwest corner is marked by a **4'x4" Post 4** feet
 high, inscribed "SW Corner of the **NEE 126** Claim;" the southeast corner is marked by
 a **4' PIPE 4** feet high, inscribed "SE Corner of the **NEE 126** Claim;" the
 northeast corner is marked by a **4" PIPE 4** feet high, inscribed "NE Corner of the
NEE 126 Claim." There is also a **4" PIPE OR 4'x4" Post** at the center of each side line.

 (must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
