We (or I) claim **1500** linear feet along the course of the mineral-bearing ledge, lode or vein, extending **20** feet from the location monument in a **EASTERLY** direction, and **1480** feet in a **WESTERLY** direction, together with **300** feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a **4 in.
