each side of the center of the ledge for the entire length of the claim.

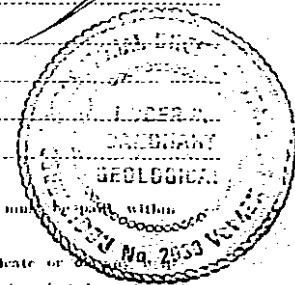
The northwest corner is marked by a **4" x 4" Post 4** feet high, inscribed "NW Corner

northeast corner is marked by a **4" x 4" Post 4** feet high, inscribed "NE Corner of the  
**NEE 134** Claim." There is also a **4" x 4" Post** at the center of each side line.

The monumentation and marking of the corners was completed by the **12<sup>TH</sup>** day of **JUNE**, 19**76**.  
(must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this  
claim map have been filed with the **EUREKA** County Recorder, and the \$15.00 lode claim  
filing fee has been paid to the County Recorder.
