We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or  
 vein, extending 1480 feet from the location monument in a EASTERLY direction,  
 and 20 feet in a WESTERLY direction, together with 300 feet on  
 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner  
 of the NEE 136 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet  
 high, inscribed "SW Corner of the NEE 136 Claim;" the southeast corner is marked by  
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 136 Claim;" the  
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the  
NEE 136 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 29<sup>th</sup> day of JUNE, 1976.  
(must be within 20 days of posting notice of location)

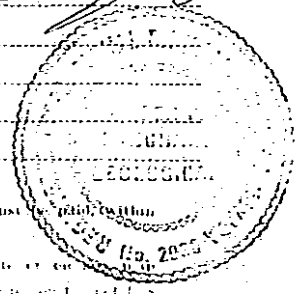
The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this

Note 1: Two copies of this certificate and two copies of the claim map must be filed, and the \$15 filing fee must be paid within 30 days after the date of posting Notice of Location.

Note 2: Every person who willfully and knowingly makes a false material statement on the location certificate or on any other document required by this chapter, shall be guilty of a felony, and upon conviction thereof shall be punished by imprisonment in the State Prison for a term not exceeding 10 years.

Note 3: The claim is located in Eureka
