# CERTIFICATE OF LOCATION

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner of the NEE 142 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet high, inscribed "SW Corner of the NEE 142 Claim;" the southeast corner is marked by a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 142 Claim;" the northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the NEE 142 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 8<sup>TH</sup> day of JUNE, 1976.

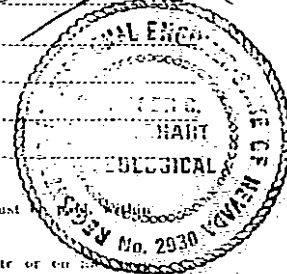
