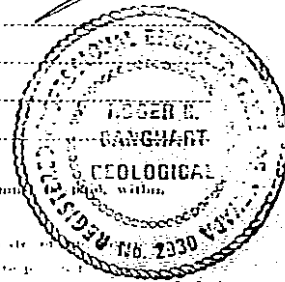

claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
