The northwest corner is marked by a 4" x 4" post 4 feet high, inscribed "NW Corner
 of the NEE 153 Claim;" the southwest corner is marked by a 4" x 4" post 4 feet
 high, inscribed "SW Corner of the NEE 153 Claim;" the southeast corner is marked by
 a 4" x 4" post 4 feet high, inscribed "SE Corner of the NEE 153 Claim;" the
 northeast corner is marked by a 4" x 4" post 4 feet high, inscribed "NE Corner of the
NEE 153 Claim." There is also a 4" x 4" post at the center of each side line.

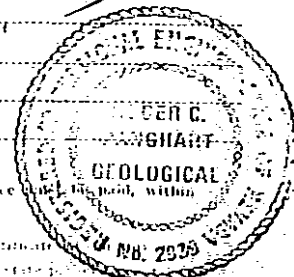
The monumentation and marking of the corners was completed by the 16th day of JUNE, 1976.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
 claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
 filing fee has been paid to the County Recorder.
