We for 1) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or

 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner
 of the NEE 161 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet
 high, inscribed "SW Corner of the NEE 161 Claim;" the southeast corner is marked by
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 161 Claim;" the
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
NEE 161 Claim." There is also a 4"x4" Post at the center of each side line.

The monumentation and marking of the corners was completed by the 2nd day of JULY, 1976.
 (must be within 30 days of posting notice of location)


The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
