 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
NEE 162 Claim." There is also a 4"x4" Post at the center of each side line.

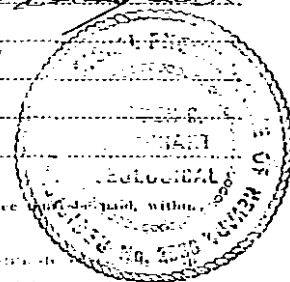
The monumentation and marking of the corners was completed by the 15th day of JUNE, 1976.
