 northeast corner is marked by a 4"x4" post 4 feet high, inscribed "NE Corner of the
N.E.E. 163 Claim." There is also a 4"x4" post at the center of each side line.

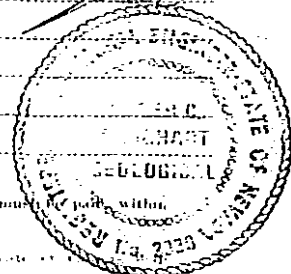
The monumentation and marking of the corners was completed by the 15TH day of JUNE, 1976.
