THIS IS TO CERTIFY that the NEE 169 lode mining claim

CORTEZ Mining District, EUREKA County, State of

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or
 vein, extending 20 feet from the location monument in a EASTERLY direction,
 and 1480 feet in a WESTERLY direction, together with 300 feet on
 each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a 4"x4" Post 4 feet high, inscribed "NW Corner
 of the NEE 169 Claim;" the southwest corner is marked by a 4"x4" Post 4 feet
 high, inscribed "SW Corner of the NEE 169 Claim;" the southeast corner is marked by
 a 4"x4" Post 4 feet high, inscribed "SE Corner of the NEE 169 Claim;" the
 northeast corner is marked by a 4"x4" Post 4 feet high, inscribed "NE Corner of the
NEE 169 Claim." There is also a 4"x4" Post at the center of each side line.


The monumentation and marking of the corners was completed by the 25th day of JUNE, 1976.
 (must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this
 claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim
 filing fee has been paid to the County Recorder.
