NEE 170 Claim." There is also a 4" x 4" POST at the center of each side line.

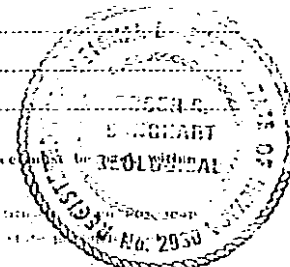
The monumentation and marking of the corners was completed by the 2ND day of JULY, 1976.
